Supporting Prisoners' Families What Can GP Surgeries and Health Centres Do?

You may already be aware of the needs of prisoners' and offenders' families, but you may not be aware of the services which can support them, or the resources available. This briefing sheet is intended to give you that information. Key Facts

- 200,000 children have a parent sent to prison each year
- More children are affected by parental imprisonment than by divorce
- These children are more than twice as likely to suffer from mental health problems than their peers
- 2/3 of boys with a parent in prison are likely to become offenders themselves

Information for families

There are many publications that can guide families through imprisonment. Prominently display Offenders' Families Helpline leaflets and posters and other sources of support in consulting rooms and surgery waiting rooms (please see the reverse of this sheet for a list of useful resources).

Identifying issues affecting families of prisoners and offenders

Ensure your health support team are aware of how imprisonment may impact on families. Family need should always be taken into account, not just when there is a safeguarding issue. Find out if other agencies are working with a prisoner's family. Children's centres, schools and voluntary organisations can help to support families, and there is a growing remit to meet the needs of offenders' families. Ensure you are aware of national and local support and can tell patients and their families about it. Make sure that families affected by drug or alcohol abuse issues, domestic violence, or physical or mental health problems are aware of the services available to them. (see helplines on the reverse of this sheet).

Liaising with the prison health centre

The imprisoned family member may be your patient. Liaison with the health professionals at the prison may be possible. The family may ask for advice on alcohol or drug issues in preparation for the prisoner's release. Refer families to ADFAM (see further on in the briefing).

Casework conferencing

As families do not always want to be open about a family member being in prison, casework meetings are good opportunities for the families to share information with the health workers based at your surgery. Make sure your workers – e.g. health visitors and practice nurses are made aware of the information and support available (see next section).
